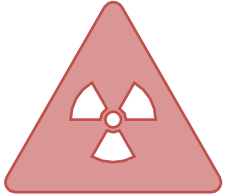

POTENTIAL THREATS TO DOCUMENTS



THREAT	DESCRIPTION	IMPACT/RESULT
Counterfeiting	Unauthorized reproduction of a valid document.	Multiple similar documents containing identical data, both appearing authentic to the untrained eye.
Tampering	Unauthorized modification of a previously valid document, e.g. to change an amount printed on the document.	An inauthentic document containing invalid data.
Imitation	Unauthorized creation of a document that looks like an authentic certificate/permits, possibly containing arbitrary data. Typically done via tools such as Photoshop.	An inauthentic document that may contain arbitrary or valid data.

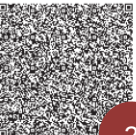

SAMPLE

1. WATERMARK

- Single layer Copy-fragile Optical Watermark for softcopies (e.g. PDF documents).
- Customized with “Government of the Republic of Trinidad and Tobago” text.
- Used to prevent misuse and unwanted alterations of document. May defer or deteriorate when photocopied.
- If watermark is suspected to be inconclusive, it is recommended to verify SecureCODE to detect document tampering.

2. SECURECODE

- SecureCODE contains encoded and digitally signed document data.
- Data is signed using industry standard algorithm ensuring it is protected eliminating unauthorised modification and forging of document contents.
- Uses PKI to protect keys
- Can be verified using Mobile App - available for iOS and Android platforms

VERIFICATION STEPS

1. DOWNLOAD MOBILE APP

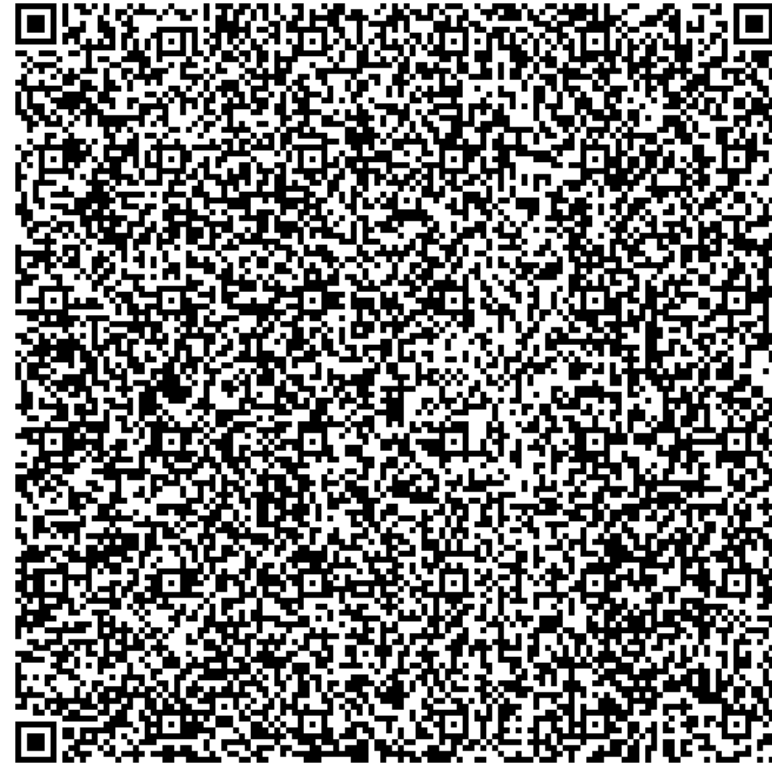
- Download Phidélity SecureCODE Verifier (freely available generic version) from respective stores by scanning below barcodes

2. ADD VERIFICATION KEYS TO APP

- Run the “Phidelity SecureCODE Verifier” app and scan the barcode provided below to add the key. This will add UAT key to the app.



VERIFICATION

3. SCAN THE DOCUMENT (PRINTOUT)

- Scan the document to decode protected information and compare the results.

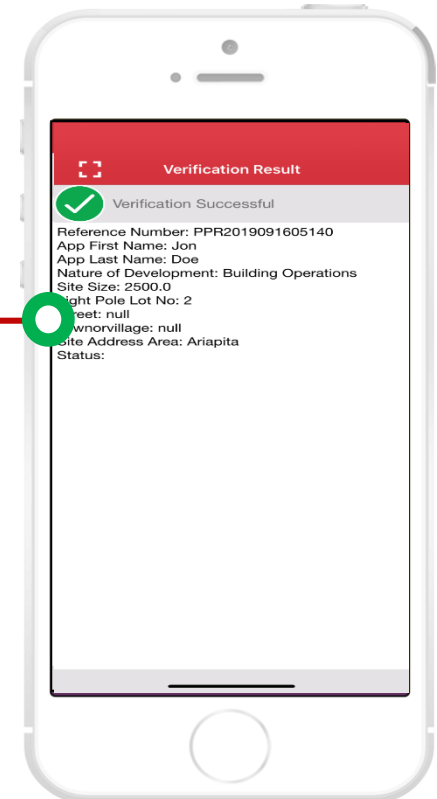

Tap on vCredits.



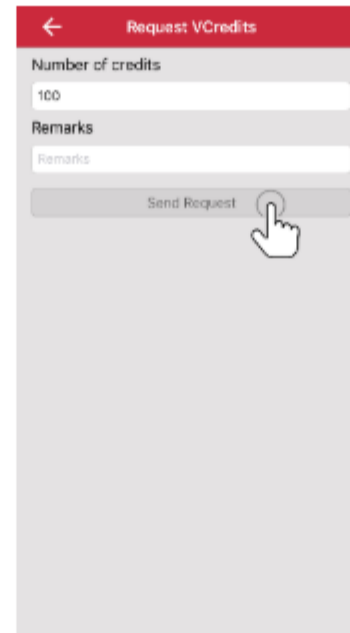
Step 2

Choose Request VCredits.



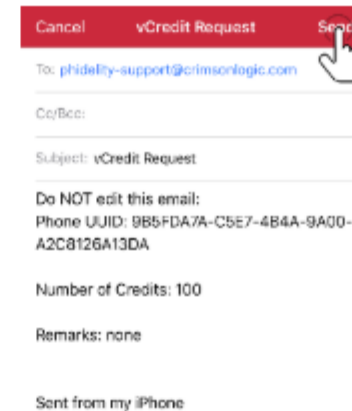
Step 3
